Ask your guardian. If your guardian won't tell you, talk to your P&A.

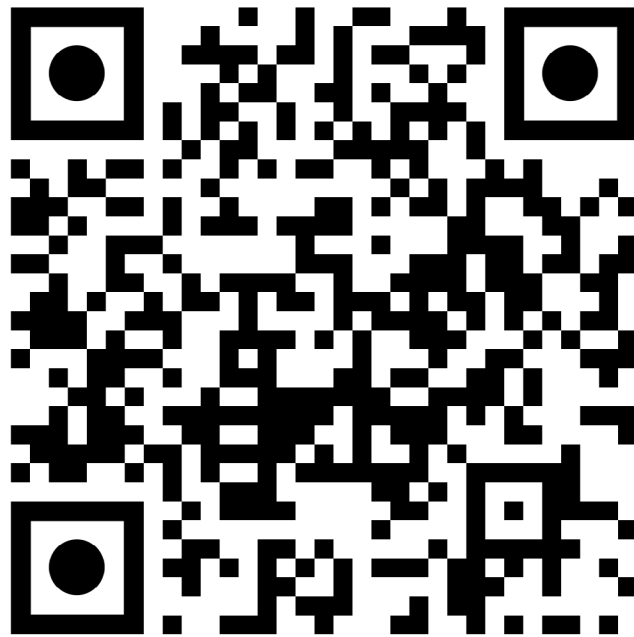
