How to Vote by Mail: A State-By-State Guide

Words to Know in this Guide



County

An area of government smaller than a state, but bigger than a city.



County clerk

A person who runs the elections in your county.



Election Day

The day you vote on if you are not voting by mail or early voting. Election Day in 2022 is November 8th.



Election office

A group of people who run the elections in your area.



Notary public

An official witness. Notary publics get special training to sign documents. Only 1 notary public needs to watch you fill out your ballot.



Photo ID

Proof of your identity. It must have a picture of you. Examples of photo ID are: driver's license or a state ID card.



Witness

A witness is someone that watches while you fill out your ballot. Witnesses sign to say that you are the one that filled out your own ballot. A witness cannot tell you how to vote. They cannot look at your ballot. They should just sign where it says witness.






• A child or spouse of any of the above.



You are an appointed election officer or poll watcher at a polling place other than your regular polling place.



 An appointed election officer or poll watcher are people who work at the polling place to help with the election.



• A polling place is where people can go to vote in person.



 You expect to work a required shift of 10 hours or more that happens at the same time as polling.



 You are currently in prison or jail and have not been convicted of a felony involving "moral turpitude". "Moral turpitude" is a kind of crime.

How do I get my ballot?



A ballot is the piece of paper you use to vote.

Put the copy of your photo ID in the envelope with the form.



Look at the top of your application.



You should mail the application to that address.



You can also take the application in person.



You should then receive your ballot.





A **witness** is someone that watches while you fill out your ballot.



Witnesses sign to say that you are the one that filled out your own ballot.



A witness is not allowed to tell you how to vote.



They are not supposed to look at your ballot.



The 2 witnesses must be older than 18.



Instead of 2 witnesses, a notary public can sign the ballot.



A notary public is an official witness.



Notary publics receive special training to sign documents.



Only 1 notary public needs to watch you fill out your ballot.

What do I need to send it with my ballot?



You need to include a copy of your photo ID.



A photo ID is proof of your identity.





It must have a picture of you.

Examples of photo ID are:



• Driver's license



• State ID card



Put the copy of your photo ID in the envelope with the ballot.



 You have to be absent from your polling place on Election Day, such as for work or surgery



 You are unable to go to the polls on Election Day because of an illness or physical disability



 You are a resident of a long-term care or residential facility licensed by the state

If you do not do all these things, the government will not accept your ballot.



Try to sign the envelope the same way you usually sign your name.



If it does not match the way they think you sign your name, they will not accept it.



If your ballot is not accepted, you can't fix it.



A ballot is the piece of paper you use to vote.



You can get your ballot by phone, mail, email, or in person.



To ask for your ballot over the phone, call your county clerk.


When do I have to request my ballot?

Election Day is November 8th.




When do I have to send my ballot?
